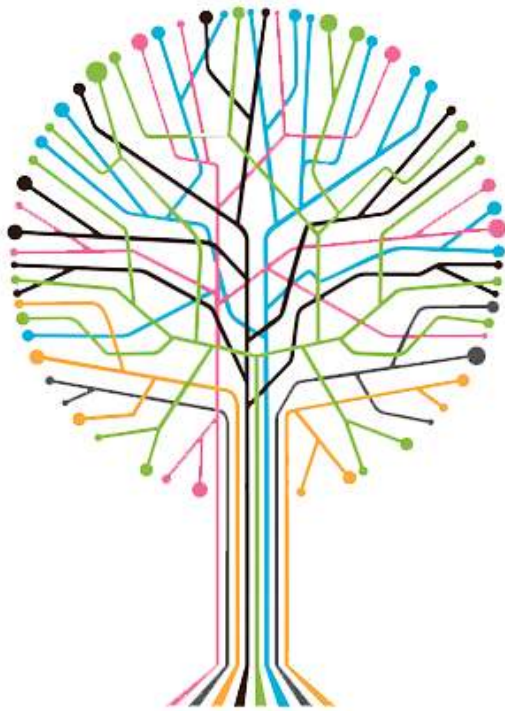

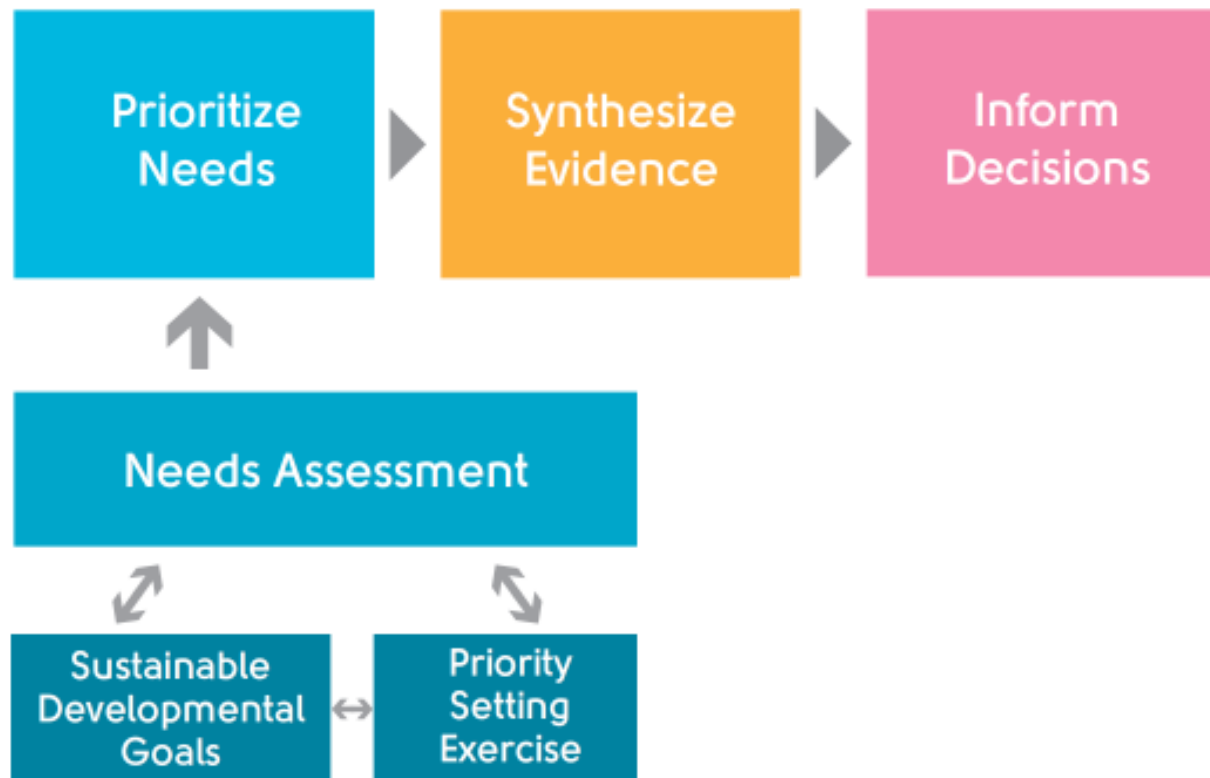

GESI Framework



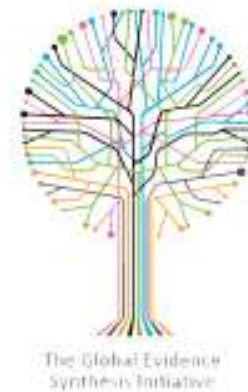
The GESI framework is a multidisciplinary approach that will build capacity in Low-and Middle-Income Countries (LMICs) to create opporutinities for:

Impact Evaluation

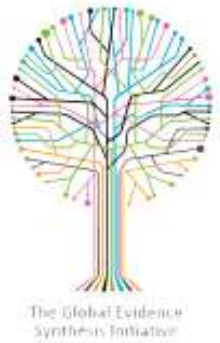

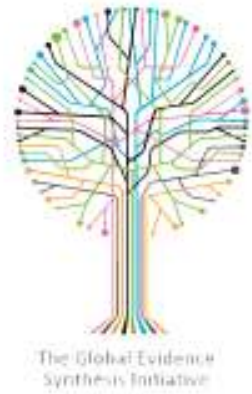

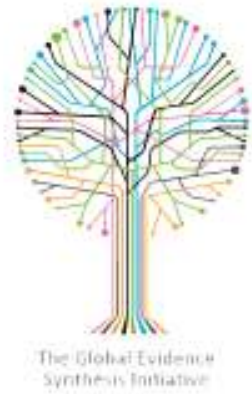
Moving Forward

- Other: infrastructure, tools & softwares, bursaries to attend international conferences

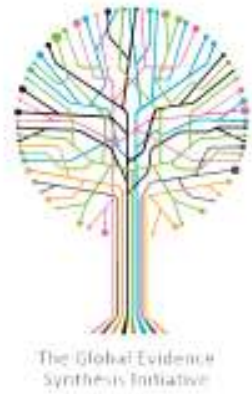
Models for partnership

 2. GESI social media (live-stream) to increase access

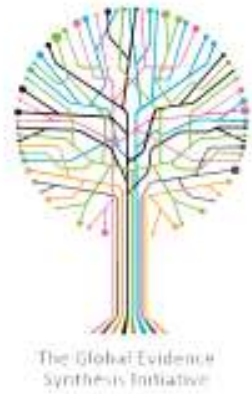
Models for partnership

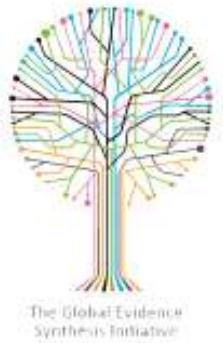
